Front Suspension: no excessive play; ball joints and tie rods secure; boots and all seals in good condition.		
Roll Bar & Cages – VIR will not allow any convertible without a fixed industry standard roll bar with the driver and passenger of that vehicle both passing the "broom stick" test in any passing group or time trials. Street cars with deployable pneumatic or electric push-up bars are not permitted.			Rear Suspension: half shaft boots in good condition; mounting hardware in good condition; no leakage.		
Pedals: All pedals must have free return and be in good operating condition. Brake pedal must be firm.			Brakes: Sufficient brake pads (50% minimum); rotors and pads are in good condition; no cuts or abrasions in brake lines. There should be no visible cracks extending to the edge of the rotor. With co-driver, pads should exceed minimum standard.		
Doors: must be operational from inside and outside.			Brake Fluid: Sufficient brake fluid; premium fluid recommended. Brake fluid must be changed at least annually.
